EN09 APOLOGIES

EN10 DECLARATIONS OF INTEREST AND DISPENSATIONS RECEIVED

EN11 MINUTES

EN12 ENVIRONMENTAL ISSUES IN THE TOWN

Members were reported that an article in the local newspaper had been published relating to waste and recycling collection changes in the North Devon area. It reported that North Devon Council were going to run a pilot scheme within North Devon for two areas before a final decision is made on the remaining areas. This scheme would see the waste collection rise to three weekly collections and also the charging of green waste per household, expected to be £36.00 a year. Whilst, the Town Council had contacted Cllr Rodney Cann regarding the scheme and was assured of consultations, this had not taken place.

Members had grave concerns regarding this change and felt that not enough consultation with the public or key organisations in the town had taken place.

Members felt that fly tipping would increase and were particularly worried about multi-occupancy properties.

After some discussion, it was

RESOLVED:

That an officer or lead member for Waste and Recycling at North Devon Council be invited to the next Environment Committee meeting to discuss the changes.
