Observations: RECOMMENDS: Refusal. No other signs in Joy Street are illuminated, the illumination in both High Street and Joy Street would have an adverse impact on the conservation area, andthe hanging sign is superfluous to the street scene.

#### REPORTED CONCERNS 95

Cllr Upcott reported the following issues:

- St Georges Road was subsiding in places due to potholes, especially at the Pilton Causeway end of the road:
- The drains on St Georges Road were obstructed and overflowing;
- Pilton Causeway was flooding due to blocked drains:
- A repair to a flagstone outside Twigs Florists in Pilton Street had been carried out using tarmac. This was detrimental to the conservation area and should have been repaired using a replacement flagstone;
- A damaged lamppost outside 26 Pilton Street had not yet been replaced;
- The paving outside Poundland in the High Street was giving way. This was detrimental to disabled and other pedestrians, and to the conservation area.

RESOLVED: That the Clerk report these issues to the appropriate bodies. (NC)
